Vaal Central Board (Former Bloem Water) derives its primary mandate from the Water Services Act, Act 108 of 1997 and is, in terms of the Public Finance Management Act (PFMA), Act 1 of 1999, Schedule 3B, a National Government business entity, which reports to the Executive Authority, represented by the Minister of Water and Sanitation through the Department of Water and Sanitation (DWS).

Vaal Central is a Water Board with the mandate to provide water services to the Southern and Central areas of the Free State Province and the Northern Cape respectively to include the entire jurisdictional area that was previously serviced by Sedibeng Water as gazetted on 26 July 2022 by the minister of Water of Water and Sanitation.

Vaal Central Water accordingly invites interested Service Providers to submit expressions of interest for the services detailed in this Expression of Interest (EOI) below.

Scope of Works (Services):

This appointment requires suitably qualified Contractors in the Civil, Mechanical and Electrical disciplines for Maintenance, Minor Construction and Refurbishment of all water and sanitation infrastructure of Vaal Central Water as and when required. More details are provided in the bid documents.

ANNEXURE B – SOURCING PROCESS FOR THIS PROJECT

Vaal Central Water conducts business in a manner that encourages good supplier relations within an environment that promotes competition and is compliant with Vaal Central Water policies and the law.

Vaal Central Water elected to adopt a 2-layerd procurement strategy in the sourcing and selection of maintenance Contractors for Vaal Central Water’s maintenance portfolio.

An overview of this process is demonstrated in the *Procurement Process Diagram* below, as detailed further in this document:




Fig 1: Procurement Process Diagram

B.1 PHASE 1: Expression of Interest (EOI)

EOI is a commonly applied business process and procurement tool that gathers written information about suitable service providers' capabilities, availability, and competitiveness in the current open market. The outcome of an EOI is a shortlist of interested, capable, and market-driven *Contractors*, streamlining the tendering phase.

EOI is a formal, auditable step in the sourcing process intended to collect information on which shortlisting is based. The process is executed strictly in accordance with Vaal Central Water's policies, procedures and requirements. The benefit of the information gathered during the EOI phase is a shortlist of potential Respondents to allow more focus in selection for the RFP process, resulting in a more transparent and efficient RFP process.

The information submitted by interested Respondents will be evaluated to ascertain:

- (i) Technical capability
- (ii) Statutory compliance
- (iii) Relevant information about various registrations and affiliations that are required and/or accessible; and
- (iv) The extent of the existing market relevant to competition
- (v) Respondents' delivery track record and performance for similar work.
- (vi) Respondents' compliance with the BBBEE codes of practice

For clarity, an EOI is a preliminary step in the sourcing process, preceding and directing the RFP to follow.

B.2 PHASE 2: Request for Proposal (RFP)

An RFP is a formal tender document that Vaal Central Water will issue to the shortlisted Respondents to solicit formal bids encompassing proposals, pricing and quotes. The RFP specifies and provides details of the required services, timelines, deliverables and evaluation criteria supporting the TSC4 Option E (cost-reimbursable contract) on which the Respondents' proposal will be assessed.

The RFP will apply the information gathered during the EOI phase and provide very specific instructions to the Respondents in the RFP, detailing the criteria that the returned bids need to comply with.

The returned bids will include both technical and commercial information, allowing for the evaluation of the bids received against the predefined measurement criteria in a fair and transparent process.

For clarity, the technical evaluation process that takes place during the EOI phase is a high-level evaluation to determine the expertise and capability of potential Respondents for the delivery of the scope. During the EOI phase, the objective is to select the correct shortlisted Respondents to streamline the RFP process. 
