Scope of Works

Regulations for Hazardous Biological Agent Section 8 (1) (a) stipulates the employer shall ensure that an employee is under medical surveillance if the results of the Risk Assessment indicate that an employee might be exposed to HBA.

1. The employer shall after extensive counselling and education offer the employee the opportunity to have;
 - i. Initial evaluation of the employee's medical and occupational history
 - ii. Physical examination
 - iii. And any biological test or other appropriate medical test

The Occupational Medical Practitioner(s) registered with Health Professions Council of South Africa are required to render the following services to Vaal Central Water Board:

- Glucose Test;
- Audiometric Screening (Registration of staff onto the register of Audiometry's as required by the Occupational Health and Safety Act, Act 85 of 1993 with SASOHN (South African Society of Occupational Health Nurses);
- Spirometry/Lung Function Screening;
- Chest X-rays where applicable;
- Keystone Vision Screening/Visual Screening;
- A physical Examination;
- Hypertension (Blood Pressure);
- Medical History i.e. chronic medication, current medication, illness etc.;
- Multi drug and alcohol testing followed by confirmation test if not negative;
- Conduct any assessment as required by applicable legislation/s; and
- Pregnancy examination for safety critical grades.
- Hepatitis A & B vaccination for employees working with hazardous waste (waste water treatment works)
- An evaluation of the individual's history of general health and previous occupational health;

A general health WH and the completion of a questionnaire to be signed by the prospective employee concerned;

7. Issue Medical Certificate of Fitness to employees working at heights.
8. Issue Medical Certificate of Fitness to employees working in confined spaces.

preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
