Appearance: Small to medium-sized tree with drooping branches and trifoliate leaves.

2. Sweet Thorn (*Vachellia karoo*)**

Appearance: Medium-sized thorn tree with yellow puffball flowers.

3. Wild Olive (*Olea europaea* subsp. *africana*)**

Appearance: Evergreen tree with small, leathery leaves.
